



**HOUSING CHOICE VOUCHER SECTION 8 PROGRAM
LOTTERY FREQUENTLY ASKED QUESTIONS**

Q: What is the Housing Choice Voucher (Section 8) program?

A: The Section 8 program is a federally regulated and funded program through the Department of Housing and Urban Development (HUD). The tenant-based subsidy program allows participants to select rental units within the permitted jurisdiction in the private market while paying a rent based on income.

Q: How do I apply for the Housing Choice Voucher (Section 8) program?

A: The Section 8 program at Brighton Housing Authority (BHA) is a lottery-based application process being offered online. Online entries can be submitted at www.brightonhousingauthority.org within the time frame allotted. Accepted entries will be placed on BHA's wait list for the applicable year. The dates of the lottery change yearly and are posted on our website and in the legal section of the local newspaper.

Q: What are the qualifications? / Who can apply?

A: Generally all interested applicants must be: 18 years of age or older, cannot exceed the Area Median Income Limits, pass a criminal background check, U.S. citizen or have at least one household member with eligible immigration status.

Q: Do I have to live in Brighton to apply?

A: No, you do not have to live in Brighton to apply. However, BHA has adopted a local preference and you will be required to lease a unit within the BHA jurisdiction for the first 12 months if you receive assistance.

Q: Can I submit more than one online entry?

A: No, duplicate entries will be disqualified.

Q: How can I track the status of my online entry?

A: You may review your application status through the registered online account needed to apply at www.brightonhousingauthority.org.

Q: What if I have to report a change of address or other changes to my household?

A: It is the applicant's responsibility to login to the registered online account required to apply and update any changes that occur to the household's composition, income, and/or contact information while they remain on the lottery waitlist. Generally you cannot add any additional people to your entry if your number is selected.

Q: If my number gets drawn am I guaranteed assistance?

A: If an applicant's number is drawn, they will be notified through their online registered account to complete the application and eligibility process. *Assistance is not guaranteed.*

Eligibility process includes:

- Complete online application
- Upload all required documents to online registered account: ID's, Birth Certificates, Social Security cards, verification of any income, as well as verification of court awarded custody (if applicable)
- Meet eligible income and local or homeless preference requirements

Q: How long does it take to receive assistance once I am approved?

A: The wait time will depend on funding availability. Funding must be available before another applicant can be drawn from the lottery waitlist.

Q: How does the lottery process work?

A: This year, all applications will be accepted online only. *No paper applications will be accepted.*

BHA will close the lottery at 5:00pm according to the BHA phone system clock on Friday October 1, 2021. Online entries submitted and accepted within the time frame allotted will be placed on BHA's wait list for 2022. Throughout the following year BHA will draw numbers randomly from the lottery waitlist.
